The Application deadline for October 11, 2025, Craft Show is September 30, 2025

- 1) The doors will open at 7:00 a.m. and there will be volunteers to assist you in unloading your crafts. Please plan your set up time accordingly. Your space fee includes a light breakfast (pastries & beverage per person).
- 2) Spaces should be set up no later than 9:50 a.m. No breakdown of space before 3:00 p.m. only condensing
- 3) Lunch is offered at a minimal cost for Artisans and shoppers all day beginning at 11:00 a.m.
- 4) If you wish to have wall space and/or electricity it is on a first come first serve basis at no additional cost.
- 5) All items must primarily be original. Only the items specified on the Participant Application may be sold. No commercial resale items.
- 6) The show is not juried, and we do reserve the right to limit excessive duplication of crafts.
- 7) Space fees will go to the American Legion Operation Comfort Warriors. To learn more, go to [legion.org/OCW](http://legion.org/OCW)
- 8) The space fees are NONREFUNDABLE. All tables must be draped, no lower than one inch from the floor.  
  
The tables are 8' long and 2' wide. Spaces are 10' long and 6' in width.
- 9) The safety of each exhibit is the responsibility of the artisans. Please make sure things are secure and will not topple over. NO adhesives are allowed on the walls. Space switching allowed only in agreement with the other artisans and the notification to the chairperson.
- 10) Artisans should carry their own insurance. American Legion Post 290, it's entities, or the Auxiliary Unit 290 are not responsible for the loss or damage to exhibits or vendors. All vendors are responsible for the collection and submission of the appropriate sales tax as well as the cash needed to make change. There is an ATM on site.

No ALCOHOLIC beverages will be permitted on the grounds at any time. No smoking inside the facility. Please feel free to bring a non-alcoholic drink, snacks, and/or lunch though lunch will be served to Artisans and shoppers at a minimal cost.
